

# The Pierre Chastain **Family Association**

Established in 1975, the Pierre Chastain Family Association is dedicated to the preservation and development of records and data about Chastain families. The Chastain name has varied spellings, with the most common variations being Castine, Chastaine, Chasteen, Chasten, Chesteen, Shastine, and Shastid. Unless your ancestors are recent immigrants, it is thought that most people who use one of these spelling variations are descendants of Dr. Pierre Chastain, a French Huguenot who migrated to America in 1700.

The Pierre Chastain Family Association maintains historical and genealogical information on thousands of Chastain descendants. The PCFA's genealogist, serving in a volunteer capacity (as do all board members), supervises and directs the compilation of genealogical records of the ancestors and descendants of Pierre Chastain, provides the membership with assistance in accessing data and gives research tips and advice to those doing further research on Chastain and related genealogy. Send your genealogical data (GEDCOMs, lineage, etc.) to our genealogist. The association has a historian who directs the compilations and writing of biographies, family histories, and personal histories pertaining to ancestors and descendants of Pierre Chastain.

Membership consists of, but is not limited to, known and probable descendants of Pierre Chastain. The price of annual membership is \$20.00 and is a family membership that is effective the first of January each year. A life membership may also be purchased for \$200.00. All membership inquiries and renewals should be sent to the membership chair.

The results will come to you but also be shared with the PCFA research team.

We are investigating the possibility of putting *The Chestnut Tree* out as a digital PDF version. We're looking into whether to put it online on our Web site or send it out via e-mail. So, you who prefer a digital copy will have the ability to carry it with you on genealogical

trips, but we're hoping it will save the PCFA money as well. Stay tuned for more information as we explore the pros and cons.

And, of course, that brings us to our reunion. We are still hoping to have a reunion in 2021, but so much hinges on the COVID-19 vaccines and what happens between now and the end of the year. It's difficult to predict whether our lives will have returned to normal by then, or whether we will still be in disarray. Being an optimist, I will make plans to attend. Just be aware that we may have to make quick decisions as the year progresses.

# **DNA**How Are We Related?







## Obituary: Herschel L. Chastain

Herschel Lute Chastain, of Lamar County, Mississippi, born June 22, 1934, passed away December 1, 2020, in his "Silver Bullet" motor home at his daughter's house in Dickson, Tennessee. Funeral services were planned for 1:30 p.m. on December 19, 2020, at the Hattiesburg Chapel of Moore Funeral Home with interment in Clear Branch Cemetery to follow.

Herschel was the husband of Virgie Whiddon Chastain. They were married on August 12th, 1956, and shared 64 years of adventures. He was a member of Friendly Baptist Church in Branson, Missouri. He will be remembered for his calm, loving and hardworking nature. He was self-educated and prided himself on always looking his best. One would never find him without a comb in his pocket.

He grew up in Mississippi but met and married his wife and had all three of his children in Dallas, Texas. He then moved back to Lamar County to care for his mother and to raise his family. He was a farmer and machinist. He retired from Amerada Hess in 1993. He loved

managing his stock market accounts and was always watching CNBC.

Traveling with his wife and travel buddies around the States in a 5th wheel was a huge source of joy for him, and second only to spending time with his grandchildren and greatgrandchildren. He also enjoyed genealogy research of the Chastain and Green families; he was proud to have traced his roots back to Dr. Pierre Chastain, a French Huguenot who migrated to America in 1700. He was preceded in death by his mother, Eula Francis Green Chastain, and father, Bunyon Montgomery Chastain; sister, Imogene Davis; brother, Ben Eldred Chastain; and son Karl Wade Chastain.

He is survived by his wife, Virgie Whiddon Chastain; daughters Deborah Chastain Kitchen of Dickson, Tennessee, and Sharlene Chastain Joh of Franklin, Georgia; sons-in-law, Paul



Kitchen and Fritz Joh; grandchildren and spouses, Danielle and Hunter Dehn of Dallas, Texas; Karlin and Mitch Foor of Williamsburg, Virginia; Charlotte Trené and Zach Moody of Wedowee, Alabama; Victoria, Frederick, Sterling, Leopold Joh of Franklin, Gergia; Austin Kitchen of Dickson, Tennessee; great-grandchildren Sky, Star, Landon and Savannah Dehn of Dallas, and one little Moody on the way. He is also survived by many beloved nieces and nephews. His family is celebrating their patriarch, "Hershey-bar," "Daddy," "Pawpaw," "Papa" being in Heaven with his Lord and Savior Jesus Christ and son Karl.

### **Thomas Chastain: Crime novelist**


A voracious reader from a young age, Thomas Floyd Chastain, Jr., had a long career as a writer in many fields, from newspapers, advertising, and magazine freelancing to radio scripts. But in the 1970s and '80s he became well known as a novelist, specializing in crime, suspense, and mystery books.

Chastain's first major suspense novel was *Pandora's Box* (1974), followed by 9-1-1 (1976), *Vital Statistics* (1977), *High Voltage* (1979), *The Diamond Exchange* (1981), and *Nightscape* (1982).


In 1983, Bill Adler commissioned Thomas Chastain to write the mystery contest novel Who Killed the Robins Family? — a hardcover book that depicted a number of murders, giving clues but no answers to the mysteries. The publisher challenged readers to submit their solutions to the murder mysteries for a \$10,000 prize. On January 29, 1984, the book topped the New York Times Best Seller List for fiction (knocking Stephen King's Pet Sematary to second on the list). After the contest was over, a subsequent paperback edition revealed the answers to the mysteries.

Thomas Chastain continued writing through the 1980s and '90s, including a couple Perry Mason novels (based on the fictional lawyer created by the late Erle Stanley Gardner).

In 1989, Thomas Chastain served as president of Mystery Writers of America (a post previously held by such notable authors as Ellery Queen, Raymond Chandler, Robert Bloch, and Mary Higgins Clark).









Thomas Chastain contributed to the animated TV series *The Simpsons*, co-writing the 1992 mystery-themed episode titled "Black Widower," in which Bart Simpson's nemesis, Sideshow Bob (voiced by Kelsey Grammer), got out of prison and married Bart's aunt Selma. Bart followed a series of clues to foil Bob's plot to murder Selma for her money.

Thomas F. Chastain, Jr., died from lung cancer on September 1, 1994, in New York City.

### Chastain ancestors

Author Thomas Floyd Chastain, Jr., was born on January 17, 1921, in Nova Scotia, Canada, but grew up in the southeastern United States. His parents were Thomas Floyd Chastain, Sr. (an Alabama native), and Katherine Powers (of Nova Scotia, Canada).

His father, Thomas Floyd Chastain, Sr., was born in 1896 to Robert Thomas Chastain (#1841 in the book *Pierre Chastain and his Descendants, Vol. II*) and Emma Oliver. Robert Thomas Chastain, born around 1870 in Alabama, was the son of Thomas William Chastain (#725 in the book *Pierre Chastain and his Descendants, Vol. II*).

Thomas-William Chastain was the son of Raney Chastain (#226 in the book *Pierre Chastain and his Descendants, Vol. I*), who was born 1811 in South Carolina to William Chastain (#67). William was the son of Abraham Chastain (#16).

Abraham Chastain was the son of Pierre Chastain, Jr. (#5), whose parents were Huguenot immigrants Pierre Chastain and Anne Soblet.

## The Pierre Chastain Family Association

In 1975, Elby F. Bowman sent invitations to fellow Chastain researchers to attend a "conference" on the interests of further research and the coordination of these efforts into a society or association. A group of interested parties met on August 31, 1975, at Dyer, Arkansas, and the Pierre Chastain Family Association was born! The following were charter members from this organizational meeting.

The organization was founded with J. E. Chastain as President, Thomas V. Creekmore as First Vice President, Lucille C. Anderson as Second Vice President, Geraldine Buland as Secretary-Treasurer, and Elby Bowman as Genealogist.

The first issue of the association's newsletter, *The Chestnut Tree*, was released to the membership in January of 1976. Volume One, Number One of *The Chestnut Tree* was a total of four pages, hand-typed, photocopied, and one-sided. By the release of this first issue, the membership had grown to 42 members.

Today, the Pierre Chastain Family Association has approximately 220 members. There is also an extensive computer database, maintained by the association's genealogist, which contains information submitted by the membership in their research, as well as numerous census, legal, Bible, and other records documenting the lineages of Chastain descendants, sometimes covering 12 or more generations.

The present membership, and all interested in Chastain and related family history, are very grateful for the efforts of these founding members. These efforts have culminated in great documentation that allows almost instant lineage verification. These efforts have placed this material in print, in volumes such as *Pierre Chastain and His Descendants*, for generations to come. We thank you!
