Send your genealogical data (GEDCOMs, lineage, etc.) to our genealogist. The association has a historian who directs the compilations and writing of biographies, family histories, and personal histories pertaining to ancestors and descendants of Pierre Chastain.

Membership consists of, but is not limited to, known and probable descendants of Pierre Chastain. The price of annual membership is \$20.00 and is a family membership that is effective the first of January each year. A life membership may also be purchased for \$200.00. 

Additional Information on Family and Descendants, John Chastain (page 115, Volume I)

A continued effort to document additional information on, and correct where possible previously published data on, lines of descent from Pierre Chastain, and to document in our official publications those families whose ancestry is uncertain and previously unpublished, this series of articles serves as an *Errata and Addenda II* for the *Pierre Chastain and His Descendants* books. This narrative outlines additional information on the family and descendants of John Chastain (*Pierre Chastain and His Descendants, Volume I*, page 115, #100).

There are some minor corrections from *Volume I*, but the bulk is research analysis of additional demographic and legal documentation for the subjects. Minor children included in enumerations prior to 1850 are related and the four known children who survived to be adults have greatly expanded profiles, including children and grandchildren.

Please send any further additions and/or corrections on this, or any other lineage, whether previously published in *Pierre Chastain and His Descendants* or *The Chestnut Tree*.

100. John Chastain (Peter<sup>3</sup>, Rene<sup>2</sup>, Sr., Pierre<sup>1</sup>)

1. **John<sup>4</sup> Chastain** (Peter<sup>3</sup>, Rene<sup>2</sup>, Sr., Pierre<sup>1</sup>), son of Peter and Sarah (Porter) Chastain, was born between 1766 and 1774 probably in Virginia, since his birth was prior to 1774 and probably prior to the arrival of his father (Peter) and grandfather (Rene) in South Carolina, and died circa 1836 in Abbeville District, South Carolina. He married about 1795 probably in South Carolina, Frances Cain, who was born about 1775 and died between 1820 and 1830 in Abbeville District. The John Chastain household recorded in the 1800 Abbeville District, SC, Federal Census is the apparent son of Peter Chastain and his alleged first wife Sarah Porter. John's wife's name is recorded as Frances Cain in numerous early DAR and SAR documents, applications from her grandchildren. John and Frances would have married between 1790-95

based on the births of the children. John is probably one of the occupants of his father's home (Peter) in 1790 and married shortly thereafter. The 1800 Census is John's first enumeration and his name is rendered as Shatteen or Shottean. He is again noted in Abbeville Federal Censuses to 1820 and is highly likely as the elder male in James Chastain's household in 1830, also in Abbeville, Frances likely dying in the 1820s. The Census enumerations are fairly consistent, the 1810 and 1820 records increment as expected of a growing family. The 1800 record contains a male born prior to 1790 and a female born in or earlier than 1800. The male is not recorded again, possibly a child but more so a potential sibling of either John or Frances. The female could be one of the three females seen in later Census records.

The 1810 census implies some 7 minors that are probable children, 5 under the age of 10 (2 males and 3 females) and 2 (males) age 10-15. So, it would appear that children were born as early as 1795. The 1820 enumeration again notes some 7 members that are potential offspring with one potential addition of a male child under 10. In comparing the brackets for the three census records, it would appear that John had at least 8 children, possibly 10 if the male of 1800 is included and the female of 1800 differs from those recorded in 1810 and 1820. There are certainly 3 males born 1795-1802, 1 male born between 1802-1804, and 3 females born between 1800 and 1809 with one apparently born in or after 1804. Since John's will only mentioned 5 children, at least 3 are unknown and potentially died prior to his death.

Both the eldest male and female of 1800 were included in the 26-to-44 age bracket, born between 1756 and 1774. Both were again included in this bracket in 1810 thus narrowing the range 1766 to 1774. In 1820 the eldest male was noted as greater than 45 (born prior to 1775) while the female was once again rendered as 26 to 45 (born 1776 to 1794). So, it would seem that John was born between 1766 and 1774 and Frances possibly somewhat younger in this same range.

John was not listed as head of household in 1830 but he could be the elder male residing in the home of James Chastain that Census year. However the age of the older male in James's home is increased to a birth circa 1755. There is not a female of age to be Frances noted in any of the children's homes; she apparently died in the 1820s.

John's will was written 28 May 1834 and probated 17 Jul 1837. His son Allen B. Chastain and his son-in-law, Henry Hoes, were named as executors. Sons James, William and John and daughter Beersheba Hoes were included as heirs. Frances was not mentioned, nor were other potential children or grandchildren. Witnesses were Thomas Ferguson, Samuel Edmonds, and Fredrick Smith.

As Allen also only mentioned the same four heirs in his will of 1847, the three unknown minors of the early Censuses were not biological children or are presumed to have died prior to 1837.

Children of John and Frances (Cain) Chastain, all born in Abbeville District, South Carolina:

- + 2 i. William<sup>5</sup> Chastain, born between 1795 and 1800; died 31 January 1854 in Lee County, Georgia; buried at Chastain Cemetery, Lee County; possibly married (1) unknown about 1815, 2) Elizabeth Ruffman and 3) 8 August 1839 in Abbeville District, Jane Laramore.
- + 3 ii. **James<sup>5</sup> Chastain**, born between 1795 and 1800; died in 1855 in Lee County; died in 1855 in Houston County, Georgia; married between 1830 and 1833 in Abbeville District, Harriett E.
  - 4 iii. Allen B.<sup>5</sup> Chastain, born between 1800 and 1802; died in October 1847 in Houston County; buried at Evergreen Cemetery, Houston County. Since Allen is not recorded on the 1840 Census he is presumed to be the older male noted in the household of his brother John M. Chastain in 1840 in Houston County, Georgia. The enumeration does not note any other adults besides John and his wife, Sophia. All minors are of correct number and age to be children of John and Sophia, thus this older male resident seems to be single.

It has been presumed that Allen was a single man, but could he be the Allen "Christin" of 1830 Edgefield, SC? If so, then he was apparently married with two children. Allen died a single man in Houston County, so, if this was his family, they had preceded him.

- 5 iv. Beersheba Elizabeth<sup>5</sup> Chastain, born 6 February 1808; died 20 October 1866 in Houston County, Georgia; buried at Evergreen Cemetery; married about 1825 in Abbeville District, SC, to Henry Hoes. Henry was born about 1814.
- 6 v. Unknown Female<sup>5</sup> Chastain, born between 1800 and 1809.

- 7 vi. Unknown Female<sup>5</sup> Chastain, born between 1800 and 1809.
- 8 vii. Unknown Male<sup>5</sup> Chastain, born between 1802 and 1804. Allen Chastain seemed to be meticulous in dividing his property with his sister and brothers; only Beersheba, James, William, and John M. were mentioned, so it seems probable that the three unknown children, including this male were deceased by 1847, if indeed they were siblings.
- + 9 viii. John Madison<sup>5</sup> Chastain, born 9 December 1807; died 2 April 1884 in Randolph County, Georgia; buried at Greenwood Cemetery, Randolph County; married 18 August 1836 in Perry, Houston County, Sophia Elvira Spivey. Sophia was born about 1819 and died in 1894.

### 350. William Chastain (John<sup>4</sup>, Peter<sup>3</sup>, Rene<sup>2</sup>, Sr., Pierre<sup>1</sup>)

2. William<sup>5</sup> Chastain (John<sup>4</sup>, Peter<sup>3</sup>, Rene<sup>2</sup>, Sr., Pierre<sup>1</sup>), son of John and Frances (Cain) Chastain, was born between 1795 and 1800 in Abbeville District, South Carolina and died on 31 January 1854 in Lee County, Georgia. He was buried at Chastain Cemetery, Lee County. He possibly married (1) about 1815, unknown, William married (2) Elizabeth Ruffman in the mid-1830s and (3) on 8 August 1839 in Abbeville District, Jane Laramore. There doesn't seem to be another logical choice for the William Chastain household recorded in 1820 in Abbeville District, South Carolina except as the son of John Chastain and Frances Cain named in John's will.

But, the household is certainly not a complete match with latter records of the household. The eldest male and the eldest female's ages are given as 26 to 45. There are 3 minors recorded, all under the age of 10, 2 males and 1 female. One would assume, based on the children's ages, a couple nearer to 26 than to 45 years old. This age bracket seems to be somewhat older than expected for William. William is missing from or not identified in the 1830 and 1840 Census records. William is the apparent husband of Elizabeth Ruffman whose obituary appeared in the Augusta Georgia Chronicle: "... death of Elizabeth Chastain, wife of William Chastain of Edgefield District, South Carolina." Elizabeth was buried in the Creswell Family Graveyard in the area that became Greenwood (Correction: not Greenville) County, South Carolina and her grave marker read: "Mrs. Elizabeth Chastain, died 2 April 1838, age 23 years." The following year, William Chastain married Jane Larrimore, 8 August 1839, Abbeville District, South Carolina.

So, if the aforementioned data regarding William's marriages are correct and considering the information provided on the 1820 Census then he was possibly married to an unidentified

person prior to Elizabeth and Jane. Elizabeth was born circa 1815 so she could not be the elder female of 1820. The three children in 1820 are unidentified in future records, had William married a widow with children, could this have been a sibling, etc.? The children recorded in the 1850 Census for his family would all be by Jane Larrimore if birth years were correctly related.

The family is recorded in 1850 in Lee County, Georgia. William gave his age as 53 (1797) and Jane as 27 (1823). Four minor children are noted in the home, but one child buried in the old Chastain Cemetery would seem to be a son, John Allen (1844-46). The daughter Mary (Frances) died in 1853 and is also buried in the Chastain Cemetery with a child who was born and died in 1852, Benjamin Allen Chastain. All the children of 1850 were recorded with births in Georgia, thus the family had relocated from South Carolina prior to 1840. William is residing very near to his brother James. And perhaps he was in Richmond County in 1840 with James. William is listed as a founder and charter member of Eureka Masonic Lodge in 1849, located in Starksville, Lodge #95, and the first in Lee County.

William was the owner of 14 slaves on the 1850 schedule and reported a real estate value of \$10,000. He was reported as the owner of 202 acres of land of the first quality and 810 acres of pine land on the 1852 tax roll for Lee County. He was the executor for A. (Allen) B. Chastain, 50 acres. And, he was the trustee for the children of James Chastain, 500 acres. William's aggregate value of land was \$7000.00; that of James was \$2300.00.

William apparently died circa 1854 as Jane had remarried about 1855 or 56 to Christian Staley. Jane, Christian, and family are located in Jackson County, Florida in 1860 and residing with her is her and William's son Morgan Chastain. Two of the other children, William and James, were residing with their apparent grandfather James Laramore in Lee County. The daughter Elizabeth is unidentified in the 1860 Census. Morgan, Martha, and James Chastain were noted as minor children in 1866 probate in Lee County with their brother William H. as their trustee, Martha apparently was born after 1850 and near or after her father's death. William H. certainly survived the Civil War as this name is noted on several documents post war in Lee County. James and Martha are unidentified past the 1866 probate record. Marriage records indicate that the daughter Elizabeth married Alonzo McKenzie and her family resided in Macon County, Georgia. Morgan left records in Randolph, Macon, and Lee Counties in the 1870s and 1880s.

There is confusion regarding the grave marker of William Chastain in the Chastain Cemetery. The transcription of marker gives a death date of 31 Jan 1854 and an age of 32 years. A photo of the grave is not available. So, who is this William born about 1822, or was the age given or transcribed incorrectly, based on the Censuses, his age should be between 55 and 60 years of age. Children of William Chastain and his wife, Jane Laramore:

i. William H.<sup>6</sup> Chastain, born about 1840 in Georgia. William was residing with his grandfather, James Larrimore at the recording of the 1860 Census, also in the home was his brother James. William H Chastain was appointed 1st Sergeant of Company F, 7th Regiment, Georgia State Troops November 22, 1861. Date of discharge not given. He then enlisted as a private in Company B, 51st Regiment, Georgia Infantry March 4, 1862 and was elected Junior 2nd Lieutenant June 12, 1862, and Captain May 1, 1863. William resigned April 22, 1864.

William applied for duty again in late 1864 but was denied. He was disqualified for any active duty; he apparently received some sort of a serious bodily injury during his service. Records show hospitalization but no cause or injury specified. His residence was given as "Macon", the county of residence of his sister Elizabeth, in his service records of 1864 but the units he served in originated in Lee County.

William H. Chastain was appointed guardian of his minor siblings, James,Martha, and Morgan in probate of Lee County, Georgia, probate date of 21May 1866. Others, besides William, providing bond security were A. (Alonzo)S. McKensie (husband of his sister Elizabeth), and William D. Green (unknown relation to family).

He was residing in Lee County on 11 Jul 1867 when he registered to vote in district 10. He is not recorded there in the 1870 Census.

- + 11 ii. Elizabeth A.<sup>6</sup> Chastain, born 14 February 1843 in Georgia; died 21 March 1890 in Macon County, Georgia ; buried at McKenzie Family Cemetery, Macon County; married Alonzo S. McKenzie. Alonzo was born on 26 January 1837 in Georgia and died on 10 January 1891 in Macon County. He was buried at McKenzie Family Cemetery.
- 12 iii.

**John Allen<sup>6</sup> Chastain**, born 22 October 1844 in Georgia; died 6 November 1846 in Lee County; buried at Chastain Cemetery.

- 13 iv. **James<sup>6</sup> Chastain**, born about 1847 in Lee County; died after 1860. James is residing with his maternal grandfather, James Laramore, in 1860, his whereabouts thereafter are currently unknown.
- 14 v. **Mary Frances<sup>6</sup> Chastain**, born in July 1849 in Lee County; died there in September 1853; buried at Chastain Cemetery.

- Benjamin Allen<sup>6</sup> Chastain, born 29 March 1852 in Lee County; died there 10 15 vi. November 1852; buried at Chastain Cemetery.
- Morgan Enoch<sup>6</sup> Chastain, born 25 September 1853 in Lee County; died 27 16 vii. +December 1918 in Macon County; buried at Felton Cemetery, Macon County; married (1) 20 December 1876 in Macon County, Victoria R. McKenzie. Victoria was born there in 1863 and died there about 1877. Morgan married (2) 17 December 1878 in Lee County, Permelia Narcissa Larrimore. Permelia was Still born about 1857.
  - Martha<sup>6</sup> Chastain, born about 1854. 17 viii.

Possible Children of William Chastain and [--?--]:

- Unknown Male<sup>6</sup> Chastain, born between 1810 and 1820. 18 ix.
- Unknown Female<sup>6</sup> Chastain, born between 1810 and 1820. 19 Х.
- Unknown Male<sup>6</sup> Chastain, born between 1810 and 1820. 20 xi.

348. James Chastain (John<sup>4</sup>, Peter<sup>3</sup>, Rene2, Sr., Pierre<sup>1</sup>)

3. James<sup>5</sup> Chastain (John<sup>4</sup>, Peter<sup>3</sup>, Rene<sup>2</sup>, Sr., Pierre<sup>1</sup>), son of John and Frances (Cain) Chastain, was born between 1795 and 1800 in Abbeville District and died in 1855 in Lee County. He died in 1855 in Houston County, Georgia. Resident of Lee in 1850 but probate of estate occurred in Houston County. James married between 1830 and 1833 in Abbeville District, Harriett E. James is recorded in Abbeville District, South Carolina as a head of household, male age 30 to 39 (1790-1799) with an older male age 70-79, his presumed father, John Chastain (1750-60) on the 1830 Federal Census. It is probable that James is the person of the same name noted in Richmond County, Georgia in 1840, same age frame but now with an apparent younger wife and three small children. Certainly he shows up in Lee County, Georgia in 1850 but the sons and wife of 1840 are not noted, however two daughters, Caroline and Frances were recorded. Caroline would seem to be the female age 0-5 on the 1840 Richmond County enumeration.

Loose notes from former PCFA Genealogist Gerre Buland references two names for sons of James Chastain: James and Richard. The only geographical reference is that James Chastain died in Lee County, Georgia, on 6 Jun 1848 and Richard on 10 Jun 1848. Births were related for James as 1833 and Richard in 1835. There is no source for the origin of this

material but the two boys match very well for what is considered James's home in 1840 in Richmond County. The 1850 mortality schedule records the death of Harriet E. Chastain, 44-year-old born in South Carolina who died of a fever, duration of 14 days, in Feb 1850, Lee County, Georgia. She is certainly a prime candidate for James's wife. James reported 6 slaves in his possession on the 1850 schedule.

Neither he nor the girls of the 1850 record haven been located in further records except for James's probate that was recorded on 2 Apr 1855, thus an inferred death of earlier in the year of 1855. But, the tax rolls of Lee County in 1852 recorded James's brother William as the trustee of 500 acres of land for the children of James Chastain. So, it would seem that James had died between the Census in 1850 and 1852. The probate was recorded in Houston County, but apparently James died in Lee County. Harriet did die in Lee County and the probability is high that she would be buried in the Chastain Cemetery, likewise for James. The probate related that John H. Hose (a son of James's sister Beersheba) was appointed guardian of Frances Chastain, this was acknowledged by Christian J. Staly (second husband of William Chastain's widow Jane Larramore) and Robert E. Hose (also son of Beersheba Chastain), Caroline was not mentioned.

5. **Beersheba Elizabeth<sup>5</sup> Chastain** (John<sup>4</sup>, Peter<sup>3</sup>, Rene<sup>2</sup>, Sr., Pierre<sup>1</sup>), daughter of John and Frances (Cain) Chastain, was born between 1800 and 1804 in Abbeville District of South Carolina according to Census enumerations but various other records including her grave marker relate a birthdate of 6 February 1808. Beersheba died on 20 October 1866 in Houston County, Georgia and was buried at Evergreen Cemetery, Houston County. She married about 1825 in Abbeville District, Henry Hoes, who was born about 1814. Beersheba should be the eldest female in the household of Henry Hose in 1830 Abbeville, South Carolina Census, age 20 to 29. The household has the appearance of a man (age 30-39) who had remarried after the loss of his first wife as there are two children, male and female, whose ages relate births 1810-15 with a second male born 1815-20. The older births are a stretch for being Beersheba's children of Beersheba.

Beersheba seems to be the B. Hose of 1840 Abbeville County, South Carolina; there are no other Hose or Hoes families listed. There are two males age 10-14 that would match the youngest males of the 1830 household and two females age 5-10 born since 1830. The eldest female rendered a birth between 1800 and 1810. However, there is a male age 50-60 (1780-90). This age is too old for Henry and if him why was he not listed as head of household? The age doesn't fit for one of Beersheba's brothers either.

By 1840 Beersheba had relocated to the proximity of her brothers in Houston County, Georgia. She is recorded as head of home with two potential children residing with her, Robert and Elizabeth Hoes. She was again recorded in Houston County in 1860 and apparently resided there until her death in 1866.

A marriage, apparently Robert's second, is recorded in 1863 for Robert E. Hose and Martha Toohe or Toole. This is should be Tooke and that Martha was the daughter of Joseph Tooke. According to Tooke family documentation, Martha died in 1868 and is buried in the Tooke Cemetery in Houston County. There are no known children from this marriage.

Robert could very well be the Robt. E. Hose recorded in Mitchell County, Georgia in the 1870 Federal Census, a 35 year old (1835) born in South Carolina. He is recorded as a farm laborer that year, head of house with three Black occupants, also farm labor. His personal estate was recorded as \$150 and real estate as \$450, much smaller than the 1860 net worth of some \$14,000. Of course this was after the Civil War and much property was lost in the form of freed slaves and personal wealth. Also it was fairly common to not report accurately because most of the south was still in "occupation", the Reconstruction period where Federal troops were still stationed in the former Confederate States.

Yet another marriage record exists, this in Decatur County, Georgia for Robert Hose to Lela Evans in 1874. This is reflected on the 1880 Census for Wakulla County, Florida that includes occupants Robt. And Leila Hose. Robert's occupation is now listed as a physician leading to the assumption that he attended some sort of medical college or program in the 1870's.

Family records indicate Robert died in Wakulla County in 1883.



# **Obituary: Lynn R. Coleman (1939-2020)**

Lynn Rogers Coleman, grandson of Naomi Lucy Love Chastain, died November 13, 2020, after a five-month hospitalization resulting from a fall at his farm in the community of Hume, Fauquier County, Virginia. (He appears on page 99 of *Chastain Kith and Kin* as a 10thgeneration descendant of Pierre Chastain.)

Lynn was born in Vernon, Texas, on August 17, 1939. After graduating from the University of Texas Law School in 1964, he practiced law in Houston, Texas, and Washington, D.C., until his death.

During his time in Washington, Lynn became general counsel and later deputy secretary of the U.S. Department of Energy.



In Virginia he became a board member of the Piedmont Environmental Council, interested in issues related to resource conservation, energy infrastructure, and historical preservation. Lynn's other interests included Civil War history and genealogy.

He is survived by his wife, Sylvia de Leon; children Sheridan Coleman Ernstmeyer of Austin, Texas; John Anthony Ross Coleman and his wife Christy Rosenthal Coleman of Taos, New Mexico; Camille de Leon Coleman of Brooklyn, New York, and Camden, Maine; and retired U.S. Marine Corporal (and current Bureau of Land Management firefighter) William Rogers de Leon Coleman of Bozeman, Montana, and Hume, Virginia. Lynn was preceded in death in 2012 by son Joseph Clinton de Leon Coleman. Grandchildren include Kenneth and Michael Ernstmeyer and Grace and Lily Rosenthal.

The organization was founded with J. E. Chastain as President, Thomas V. Creekmore as First Vice President, Lucille C. Anderson as Second Vice President, Geraldine Buland as Secretary-Treasurer, and Elby Bowman as Genealogist.

The first issue of the association's newsletter, *The Chestnut Tree*, was released to the membership in January of 1976. Volume One, Number One of *The Chestnut Tree* was a total of four pages, hand-typed, photocopied, and one-sided. By the release of this first issue, the membership had grown to 42 members.

Today, the Pierre Chastain Family Association has approximately 220 members. There is also an extensive computer database, maintained by the association's genealogist, which contains information submitted by the membership in their research, as well as numerous Census, legal, Bible, and other records documenting the lineages of Chastain descendants, sometimes covering 12 or more generations.

The present membership, and all interested in Chastain and related family history, are very grateful for the efforts of these founding members. These efforts have culminated in great documentation that allows almost instant lineage verification.
